I am honored and humbled to be nominated for a position on the AAOA Board. I am a private practice otolaryngologist in Northern Virginia, just outside of Washington, D.C.



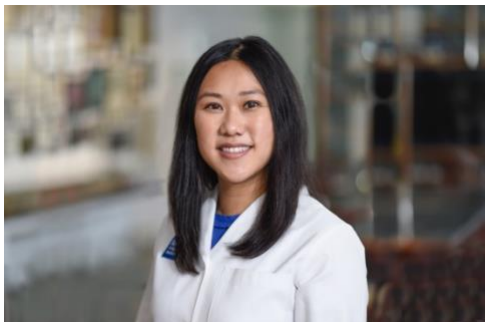
